MINUTES

LAW LIBRARY ADVISORS' MEETING

March 16, 2021

Pursuant to notice duly given, the James J. Lunsford Law Library Advisors ("Advisors") met on Tuesday, March 16, 2021, at 12:00 p.m. in the Law Library 701 E. Twiggs Street. The Advisors present were Judge Christopher Nash, James Schmidt, Esq., and Paige Greenlee, Esq. Also in attendance were Paul Johnston, Esq. (representing the County Attorney's office), Lisa Wagner and Norma Wise.

James Schmidt, as Chair, opened the meeting at 12:00 pm and followed the set agenda previously noticed.

Review and approve the Minutes of the Law Library Advisors' Meeting dated December 10, 2020.

The Minutes of the meeting of the Law Library Advisors were reviewed. There being no discussion on these Minutes, Paige Greenlee moved and Judge Nash seconded the motion to accept the Minutes as presented. The motion was passed unanimously.

Law Library Manager's Report

- a. Statistics Overview Norma Wise presented the Manager's Report updating the Advisors on comparison of the fiscal year ending February 2020 and February, 2021. Norma briefly explained that all is still going well, but the numbers are obviously down from last year as the library is still open by appointment only.
- b. Budget-Expenditure Review The Law Library's first five months of FY21's Budget was reviewed by Ms. Wise from a report prepared by Sheryl Herold, Library Services Fiscal staff member. Norma clarified that an email was sent in December 2020 on the personnel budget and why it was such a reduced amount. Sheryl Herold was contacted and she stated that the amount shown is the amount of money the Law Library was expected to receive from the Clerk's Office for FY21. Anything spent in excess of this amount would be covered by Library Services budget.

Old Business

a. Re-appointment of the Law Library Advisors for calendar year 2021 has been confirmed by the appointing authorities for Judge Nash, James Schmidt and Paige Greenlee. Susan Miles Whitaker was not in attendance and confirmation will be obtained by her for the next meeting.

further services for the Law Library.

b. James Schmidt asked Paul Johnston to review the County Ordinance and any other

governing documents concerning the Law Library Advisors to ensure the Advisors are

complying with all that is required of them.
